### **EQUIPMENT:**

Equipment and systems covered by this certificate are as follows:

### **Description of equipment**

BBJ81 Explosion-proof audio and visual caution spotlight fittings are protected by type "d", "ib" and "t". The enclosure material is aluminium alloy. The material of light transmitting part is toughened glass. The enclosure is comprised of a glass cover, a clamping ring, an enclosure ring, an enclosure, a base, plugs and a buzzer. A LED light source, a PCB, and a terminal are installed in compartment. The buzzer is assembled at the entry. There is a type "ib" protected PCB in the buzzer. Entries are provided in the enclosure for the connection of suitably certified cable glands or blanking plugs.
